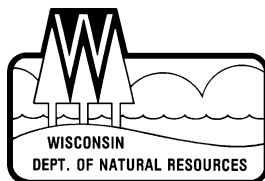

Preamble for Forfeiture and Misdemeanor Bail Schedules

- I. All persons arrested for a violation of a state or municipal forfeiture shall be released from custody without a cash bond if they:
 - Have a valid Wisconsin driver's license or can show sufficient evidence of ties to the community or
 - The arresting officer is otherwise satisfied that the accused will make future court appearances

- II. All persons arrested for a misdemeanor, including a misdemeanor traffic offense, shall be released from custody without a cash bond unless any of the following exist:
 - The accused does not have proper identification.
 - The accused appears to represent a danger of harm to himself or herself, another person or property.
 - The accused cannot show sufficient evidence of ties to the community.
 - The accused has previously failed to appear in court or failed to respond to a citation.
 - Arrest or further detention is necessary to carry out legitimate investigative action in accordance with law enforcement agency policies.

- III. All persons not released pursuant to I and II for a forfeiture, misdemeanor or misdemeanor traffic offense shall be released upon compliance with the state deposit or misdemeanor bail schedules unless the court otherwise sets bail.

These guidelines do not supersede specific statutorily mandated detention.

- The accused may be issued a citation either in the field or at the headquarters or precinct pursuant to s. 968.085(2) and s. 345.11, Wis. Stats., and may be subject to identification/booking procedures under s. 165.83.
 - A conservation citation may be issued by mail pursuant to s.23.62(2), WI Stats.

WILDLIFE VIOLATOR COMPACT

Release of Non-Residents who Commit Wildlife Related Violations:

Nonresidents arrested for a wildlife related violation may be released without a cash bond if all the following criteria are met:

1. The violator has provided adequate proof of his/her identity,
2. The violator's home state is a member of the wildlife violator compact, **AND**
3. The officer receives the recognizance of the violator and is satisfied that he or she will comply with the terms of the citation.

A wildlife related violation is defined as any violation of Ch. 29 stats., or Chs. NR 10-28, Wis. Adm. Code. (Not Ch. NR 45)

If a person fails to pay or appear in court, the DNR is required to revoke all their Hunting, Trapping & Fishing Approvals and shall not issue any new approvals to this person until they have resolved the matter by an appearance in court or payment of the penalty required.

States that are members of the Wildlife Violators Compact as of January 2009 Include:

ALASKA, ARIZONA, CALIFORNIA, COLORADO, FLORIDA, GEORGIA, IDAHO, ILLINOIS, INDIANA, IOWA, KANSAS, KENTUCKY, MARYLAND, MICHIGAN, MINNESOTA, MISSISSIPPI, MISSOURI, MONTANA, NEVADA, NEW MEXICO, NEW YORK, NORTH DAKOTA, OHIO, OREGON, SOUTH DAKOTA, TENNESSEE, UTAH, WASHINGTON, WISCONSIN, AND WYOMING.

Although the following charts have not been formally adopted by the Judicial Conference, the Supreme Court, in promulgating the schedule, concluded that law enforcement officers may find it helpful in applying the statutory factors concerning bond release.

Uniform Wisconsin Forfeiture and Criminal Bail Bond Schedule for Conservation, Environmental Protection, Boating, Snowmobile, ATV and Captive Wildlife Violations

For citations issued for civil violations, the total deposit required includes the forfeiture amount as well as all applicable surcharges and costs. For arrests for criminal violations, the applicable bail bond amount is listed following the applicable violation description. Minimum to maximum total penalties, which include the forfeiture plus all costs, fees and surcharges for each offense are indicated in parentheses after each listed violation description.

Surcharges and Court Costs are as follows:

- **Penalty Surcharge** of 26% [pursuant to s. 757.05, Wis. Stats.]
- **Natural Resources (NR) Surcharge** of 75% is applicable only to Chapters 29 and 169, Stats., and any NR Administrative Codes adopted under Chapters 29 and 169, Stats., [pursuant to s. 29.987, Stats.]
- **Weapon Surcharge** of 75% is only applicable to Chapter 167.31 violations., [pursuant to s. 167.31(5)(a), Stats.]
- **Environmental Surcharge** at 10% prior to 7-1-9 & 20% on or after 7-1-09 [pursuant to s. 299.93, Stats.]
- **Natural Resource Restitution (NRR) Surcharge** (see page 52)
- for Chapter 29 approval violations only [s. 29.989, Stats.]
- **Snowmobile Registration Restitution Surcharge** (see page 52)
- for Snowmobile Registration violations only [s. 350.115, Stats.] (Does not apply to Snowmobile Use Sticker Violations)

+ Where no deposit or bail bond is established by this schedule for a Conservation, Captive Wildlife, Environmental Protection, Boating, Snowmobile or ATV violation, the forfeiture should be set at **one-half** of the maximum forfeiture penalty as provided by law. Applicable costs, fees, and surcharges are to be added to the forfeiture amount.

In addition to any other penalty or order, a person who violates sub.(4c)(a) or (b) or (4p)(e) or who violates s.940.09 or 940.25 if the violation involves the operation of an all-terrain vehicle, shall be ordered by the court to submit to and comply with an assessment by an approved public treatment facility for an examination of the person's use of alcohol, controlled substances or controlled substance analogs. The assessment order shall comply with s.343.30(1q)(c)1.a to c. Intentional failure to comply with an assessment ordered under this paragraph constitute contempt of court punishable under ch.785.

SNOWMOBILE OWI: ALCOHOL ASSESSMENT

s.350.11(3)(d) WI stats reads:

Alcohol, controlled substances or controlled substance analogs: assessment.

In addition to any other penalty or order, a person who violates s.350.101(1) or (2) or 350.104(5) or who violates s.940.09 or 940.25 if the violation involves the operation of a snowmobile, shall be ordered by the court to submit to and comply with an assessment by an approved public treatment facility for an examination of the person's use of alcohol, controlled substances or controlled substance analogs. The assessment order shall comply with s.343.30(1q)(c)1.a to c. Intentional failure to comply with an assessment ordered under this paragraph constitutes contempt of court, punishable under ch. 785.

BOATING OWI: ALCOHOL ASSESSMENT AND MANDATORY SAFETY CLASS

s.30.80(6)(d) WI stats reads:

Alcohol, controlled substances or controlled substance analogs: examination.

In addition to any other penalty or order, a person who violates s.30.681(1) or (2) or 30.684(5) or who violates s.940.09 or 940.25 if the violation involves the operation of a motorboat, shall be ordered by the court to submit to and comply with an assessment by an approved public treatment facility for an examination of the person's use of alcohol, controlled substances or controlled substance analogs. Intentional failure to comply with an assessment ordered under this paragraph constitutes contempt of court, punishable under ch.785.

s.30.80(6)(e) WI stats reads:

Certificate of satisfactory completion of safety course.

In addition to any other penalty or order, a person who violates s.30.681(1) or (2) or 30.684(5) or who violates s.940.09 or 940.25 if the violation involves the operation of a motorboat, shall be ordered by the court to obtain a certificate of satisfactory completion of a safety course under s.30.74(1). If the person has a valid certificate at the time that the court imposes sentence, the court shall permanently revoke the certificate and order the person to obtain a certificate of satisfactory completion of a safety course under s.30.74(1).

s.30.80(2) WI stats reads:

Additionally, Boating Safety is required for ALL 30.68 violations.

Any person violating s.30.68(2) shall be fined not more than \$200 or imprisoned not more than 6 months or both. Any person violating s.30.68 shall be required to obtain a certificate of satisfactory completion of a safety course under s.30.74(1).

COMMERCIAL FISH PROTECTION SURCHARGE - PURSUANT TO S. 29.984(1) , WIS. STATS.,

- (a) If a court imposes a fine or forfeiture under s. 29.971 for the unlawful killing, catching, taking, transporting, sale, or possession of Great Lakes fish in violation of s. 29.503, or of fish in violation of s. 29.514 or 29.519, or for failing to comply with any record-keeping requirement for fish in violation of s. 29.503, 29.514, or 29.519, the court may impose a commercial fish protection surcharge that equals the amount specified for the fish under par. (b) or (bg).
- (b) Except as provided in par. (bg), the amount of the commercial fish protection surcharge shall be as follows:
1. For any commercial fish, as determined by the department, an amount equal to the average wholesale value of the fish on the date of the violation. The department shall determine the average wholesale value of the fish by determining the wholesale value of such fish purchased by 3 different wholesale fish dealers in this state on or about the date of the violation.
 2. For salmon, trout, and noncommercial game fish, an amount equal to the amount specified in s. 29.983 (1) (b) 9. to 12.
- (bg) For a fine imposed under s. 29.971 (1) (b) or (c), the amount of the commercial fish protection surcharge shall be an amount equal to 3 times the average wholesale value of the fish. Department shall determine the average wholesale value of the fish by averaging the price received by 3 different wholesale fish dealers in this state for that species of fish on or about date of violation.

To calculate the value of fish for charging purposes and for determining amount of any required Commercial Fish Protection Surcharge:

1. Salmon, trout, and noncommercial game fish shall be valued on a per-fish basis according to the dollar amounts specified under s. 29.977 (1) (a) and (i) to (L).
2. Other species of commercial fish shall be valued on a per-pound basis according to the "average wholesale value" of the fish. The department shall determine the average wholesale value of the fish by averaging the price received by 3 different wholesale fish dealers in this state for that species of fish on or about the date of the violation.
3. "Average wholesale value" means the average purchase price paid by wholesale fish dealers on the date of a violation of this chapter as determined by the department after obtaining price information from 3 wholesale fish dealers in this state.
4. For purposes of making charging and penalty determinations, the value of fish from multiple violations committed by the same person in any 12-month period may be aggregated.

FISHING SHELTER REMOVAL SURCHARGE - PURSUANT TO S. 29.985(1) , STATS.,

- (a) If a court imposes a forfeiture under s. 29.404 (3), the court shall impose a fishing shelter removal surcharge under ch. 814 equal to the costs associated with the seizure and destruction or sale of the public nuisance.

GREAT LAKES RESOURCE SURCHARGE - PURSUANT TO S. 29.9905(1) , STATS.,

- (a) If a court imposes a fine or forfeiture for a violation of s. 29.503 involving Great Lakes fish or for a violation of s. 29.514 or 29.519, the court shall impose a Great Lakes resource surcharge equal to 75 percent of the amount of the fine or forfeiture.
Note: this 75% surcharge is in addition to the 75% Natural Resources Surcharge imposed under s. 29.987, Stats.

FISHING NET REMOVAL SURCHARGE - PURSUANT TO S. 29.991(1) , STATS.,

- (a) If a court imposes a forfeiture under s. 29.931 (2) (am) for failure to reimburse the department for costs associated with the seizure of a net or similar fishing device under s. 29.931 (2) (a), the court shall impose a fishing net removal surcharge in an amount equal to the sum of those costs plus an amount equal to 75 percent of the amount of the forfeiture.
Note: this 75% surcharge is in addition to the 75% Natural Resources Surcharge imposed under s. 29.987, Stats.
