CONDITIONS ON WHICH THIS PERMIT IS ISSUED

It is the intention of the Natural Areas Preservation Council and the Department of Natural Resources to further scientific research within State Natural Areas and to cooperate with professional and technical workers to the fullest extent compatible with its obligations to protect and preserve the integrity of plant and animal communities, their component species, and other features of each State Natural Area.

1. Research on State Natural Areas (including collecting) shall be conducted in a way that preserves the area's features. In order to avoid attracting attention, all collecting must be done away from roads and trails unless specified otherwise in the permit. It may be necessary to limit the number and kind of specimens collected.
2. All collections shall be used for scientific or educational purposes only and not for private or commercial profit. Although it is not required that collected specimens be deposited in a public institution, it is urged that arrangements be made with the Milwaukee Public Museum, University of Wisconsin, or similar depository for permanently maintaining specimens of Wisconsin's flora and fauna.
3. The permit holder must notify the land manager(s) before beginning permitted activities.
4. This permit does not apply to archeological materials or to plant or animal species protected or regulated by state or federal law. To obtain permits for archeological work contact the State Archeologist at the Wisconsin State Historical Society, 816 State Street, Madison, WI 53706. To collect protected or regulated plants or animals you must obtain the appropriate permits from the Department of Natural Resources and/or the U.S. Fish and Wildlife Service.
5. The permit holder shall provide the Department and Natural Areas Preservation Council with copies or reprints of theses or publications derived from this research. Address: Natural Areas Preservation Council, Department of Natural Resources, Box 7921, Madison, Wisconsin 53707.
6. The permit holder or others authorized by the permit must carry the approved permit while conducting the research.
7. The Natural Areas Preservation Council and the Department of Natural Resources are not responsible for the safety of personnel or their equipment while using State Natural Areas.
8. The Administrator, Land Managing Agency, may terminate this permit upon the permit holder's breach of any or all the terms and conditions contained herein.
