### Information

**Social Security Number:** A social security number is REQUIRED the first time you apply for a hunting or fishing license according to s. 29.024(2g), Wis. Stats. Such number WILL NOT be disclosed to any other person except to the Department of Workforce Development to determine liability for unpaid child or family support. Once you have applied for a license, you will be assigned a DNR Customer Number, and only that number will appear in your record.

**\*Fees:** There is no transaction fee for the transfer, however some fee stipulations may apply. If a resident transfers to a resident, no money submission is required. If a resident transfers to a non-resident, the transferee must pay the difference between the fees of a resident and non-resident license. There is no fee rebate if a non-resident transfers the license to a resident. A designee may not receive payment or any other form of consideration for the transfer of preference or license.

  - Any license or permit that was issued to the deceased customer
  - License Fee (if resident transferring to non-resident)
  - Photocopy of transferee's hunter education certificate

### Application Time Requirements

Applications to transfer preference points or preference category of the deceased person must be submitted within one year of the date of death.

Applications to transfer an awarded approval or license of the deceased person must be submitted prior to the first day of the season to which the permit or license is valid.
